2. Declarations of Interest (All)

No pecuniary interests were declared. Officers of DCC declared their interest with regards the Rail Station report.

3. Minutes & matters arising of the Board meeting held on 28th June 2024 (IF)

4. Programme and Project Update Report (LW)

4a - LW updated the meeting on the projects' progress made to date. She informed the meeting that spend is increasing with more projects now making substantial claims.

4b – Rail Station Update report

LW confirmed the Board was in full support of a Rail Station in Barrow Hill for economic, social and environmental benefits. She continued to update that the Outline Business Case for Restoring Your Railway (RyR) will be submitted to DfT w/c 30th September. Following the Chancellors announcement on 29 July, the RyR Programme is to be cancelled, meaning that the Towns Fund cannot be spent with any certainty towards a Rail Station in Barrow Hill. The Full Business Case for the Town Deal was underway but was halted upon the Chancellors announcement to avoid spending any more money.

The paper was recommended to the Board and approved.
