### **3. Minutes of the last meeting held on 16<sup>th</sup> February 2022 (TG)**

All actions had been completed and progress has been made in developing the Thriving Communities work theme with general consensus to proceed and a smaller geography, perhaps to focus on the community of Barrow Hill. ### **4. Project Approvals – Exempt item under Local Government (Access to Information) Act**

#### **a. Staveley Miners Welfare Football Club Skills Academy**

This project was formally approved by Board. Town Deal funding granted of £513,000, noting a sum of £160,000, part of the total has been approved and contracted for the Car Park Phase I element and subject to the conditions contained within the reports.

#### **b. Barrow Hill Memorial Hall**

This project was formally approved by Board. Town Deal funding granted of £1,307,000 subject to the conditions contained within the reports.

#### **c. Chesterfield Canal Trust – Canal Restoration**

This project was formally approved by Board. Town Deal funding granted of £5,304,000 subject to the conditions contained within the reports.

5. Programme Activity Report (LW)  
a. Staveley Hall Paper

The report recommending an extension to the submission date of the Project Summary Document to DLUHC to enable the Heritage and planning aspects and associated costs to be worked up was presented. This was approved unanimously by Board and the formal request of a 3 month extension from the 24 March 2022 will be submitted to DLUHC for approval.

b. Hartington Industrial Park Paper

The report recommending an extension to the submission date of the Project Summary Document to DLUHC due to complexities with the routing and costings of the power supply to site was presented. This was approved unanimously by Board and the formal request of a 4 month extension from the 24 March 2022, will be submitted to DLUHC for approval.

c. Project Assurance and Approval timetable

The timeline and approval schedule were noted.

6. Chesterfield & Staveley Regeneration Route (Consultation Launch) (MR)

MR reported that the initial public consultation being led by DCC will launch on Monday. Letters and information have been posted to local residents and paper information packs will be available around the local area. TG encouraged Board members to respond and the link will be sent out for Board members to view.

**Action:** AWC to arrange for Staveley Town Council to receive a hard copy.

TG proposed that a letter of support and response to the Consultation be sent from this Town Deal Board. TG asked all Board members to review the consultation papers and that an item be added to the Board agenda for the 18 March to have a discussion and submit a letter to respond to the consultation. It will have significant impact on our Town Deal work and the projects and the local community.

TP added the CSRR is a significantly important project and supports the proposal that the Town Deal Board provide a letter of support and response to the consultation. He has previously commented that a minor alteration in the road layout at the Chesterfield side be considered. It would benefit the housing near Sainsburys by reducing noise pollution. There is a need for this road and access to services, especially Jn 29a of the M1 which would be even more relevant for the Town Deal activities and beneficial to the area.

**7. Any Other Business**

PM noted the good work locally of Edge Ministries within the community. He also reported that work in progressing for a Youth Club in Staveley, with much support from youth workers and enthusiasm from the young people of Staveley.
