

Private Sector Housing Team

We support homeowners, private landlords and tenants who live in privately rented homes in Chesterfield. We work to ensure housing is safe, secure, meets legal standards and the needs of the household.

As part of our role we:

-  Support residents with advice and practical help around energy efficiency
-  Refer residents to other council services such as our benefits advice service and specialist agencies including Warmer Derby and Derbyshire
-  Provide loans and grants for low-income households to carry out repairs and home improvements
-  Support residents to adapt their homes to better meet their needs and improve quality of life
-  Deal with disrepair, poor housing conditions and empty homes
-  Regulate landlords and housing standards and enforce the law where needed

Services we offer

Home repair assistance

We can provide financial assistance to help low-income homeowners with a medical condition or other vulnerability which is affected by their home to enable them to carry out essential home repairs, maintenance and improvements.

This could include:

- Roof repairs or replacement
- Damp proof courses and timber treatments for damp and rot
- Repairs or replacement of rotted windows and doors
- Electrical repairs and re-wiring

Energy advice

We offer free and impartial advice to homeowners and private tenants about household energy efficiency needs and requirements, including information about how you can save money by making changes to your insulation, lighting and heating systems.

Gas safe charity funding scheme

We receive funding to provide small grants for servicing and repairs of gas appliances within your home. The funding is available to homeowners who are on low income and/or have a disability and may not otherwise be able to afford to have their gas appliances serviced.

Home adaptations and Disabled Facilities Grants

We offer guidance, signposting to other agencies and financial assistance to help residents adapt their homes. A disabled facilities grant can be used to provide safe access into and around the home and adaptations such as stair lifts, ramps and level access showers. If you or someone in your home has a permanent disability, you may be eligible for a disabled facilities grant.

Private Sector Housing Enforcement Team

We work with private tenants and landlords to ensure that private rented accommodation complies with legal requirements including new responsibilities introduced by the Renters Rights Act 2025.
