# **Historic Environment SPD Scoping Document**

#### Introduction

- 1.1 The Scoping Report has been prepared for consultation on the scope and level of detail that should be included in the emerging Historic Environment Supplementary Planning Document (SPD).
- 1.2 The historic environment is a broad term that is open to individual and varied interpretations. For the purposes of this document, the historic environment relates to the surviving elements which are products of human activity. They can cover all manner of structures and areas as well as archaeological remains. These historic elements are an important part of our cultural heritage and our sense of local and national identity. Their presence adds to the quality of life by enhancing and sustaining the sense of local distinctiveness which is an important aspect of the character of the borough.
- 1.3 The historic environment is made up of a variety of individual assets, including historic buildings and structures, ruins, landscapes, parks and gardens, and scenes of historic events, in particular battlefields. The location of the historic features in the landscape and the patterns of past use and activity are also part of the historic environment.
- 1.4 The historic environment is all around us; we can see the historic environment in our landscape, the layout of fields and roads, and the remains of a wide range of past human activities. Everywhere whether rural or urban, has a historic dimension that contributes to its quality and character.
- 1.5 A well-conserved historic environment is a major driver in delivering a high quality of life for existing and future generations of Chesterfield. When combined with appropriate uses it can deliver urban renaissance and sustainable regeneration, contributing to a healthy economy, tourism and leisure related activities, and promote employment opportunity through specialist buildings crafts such as stone masonry and carpentry. Adapting and reusing the existing building stock is also a sustainable approach.

#### The Purpose of the Historic Environment SPD

- 1.6 The Supplementary Planning Document is intended to provide a mechanism through which guidance on the interpretation and application of the policies in the adopted Replacement Chesterfield Borough Council Local Plan (RCBCLP) 2006 and how it can be applied to the preservation and enhancement of the historic environment.
- 1.7 Once adopted, the SPD will become planning guidance that will supplement policies in the Replacement Chesterfield Borough Council Local Plan and

inform policies to be included in the Local Development Framework (LDF) that will replace the RCBCLP in the coming future.

- 1.8 The overarching aim is to protect and conserve the locally distinctive characteristics of the Borough's existing townscapes and landscapes whilst also ensuring that new development respects and/or enhances the existing character of distinctive localities.
- 1.9 The main objectives of the Historic Environment SPD are:
  - To provide guidance on the historic environment which should be considered in formulating development and assessing development proposals.
  - To promote better understanding and appreciation of the historic environment
  - To protect and enhance the historic environment.
  - To ensure that all development proposals take proper account of local distinctiveness.
  - To make the historic environment accessible to everyone and ensure that it is seen as something with which the whole society can identify and engage.
  - Explain how the protection of the historic environment and the promotion of opportunities for change can contribute to sustainable development.
