Chesterfield Borough Council Local Plan Timetable

This is the Local Plan Timetable for the Chesterfield Borough Local Plan (2025 to 2044).

The 2026 Regulations state that the local plan timetable must be published no later than on the earlier of—

- a) the date on which the authority make their notice of intention to commence local plan preparation available under [regulation 19\(1\)](#), or
- b) the date on which the authority make a notice of intention to commence supplementary plan preparation available under [regulation 68\(1\)](#).

This Local Plan Timetable took effect on the **17th April 2026**.

Current Development Plan

As of 17th April 2026, the Development Plan for Chesterfield Borough comprises the following documents:

- Chesterfield Borough Local Plan (adopted July 2020)
- Saved policies of the Derby & Derbyshire Waste Local Plan (adopted March 2005)
- Saved policies of the Derby and Derbyshire Minerals Local Plan (adopted 2000 and altered 2002)

The council adopted a Community Infrastructure Levy (CIL) in April 2016.

Policies in local plans and spatial development strategies should be reviewed to assess whether they need updating at least once every five years and should then be updated as necessary.

The council reviewed the Local Plan in 2024 and concluded that a new Local Plan is necessary given the change in national planning policy in December 2024 which sets a significantly higher requirement for new homes being built in Chesterfield borough. The strategic matters that the new Local Plan will cover are expected to include the following:

- **Sustainable Development**
- **Delivering Homes and Supporting Growth**
- **Creating High Quality, Sustainable Places**
- **Conserving and Enhancing the Environment**

Preparation of Chesterfield Borough Local Plan 2025 to 2044

The Plan is being prepared under the new Development Plan system introduced by the Town and Country Planning (Local Planning) (England) Regulations 2026, which came into force on 25 March 2026, and replace the previous 2012 plan-making regulations.

The new Local Plan will relate to the administrative borough of Chesterfield.

The Town and Country Planning (Local Planning) (England) Regulations 2026 Part 2 stipulate that a local plan timetable must contain the following information:

- a) the date on which the local planning authority will make their notice of intention to commence local plan preparation available under [regulation 19\(1\)](#),
- b) the date on which the local planning authority will make a notice of scoping consultation available under [regulation 20\(1\)\(b\)](#),
- c) the date on or before which representations will have to be received by the local planning authority in accordance with [regulation 20\(4\)](#) (scoping consultation),
- d) the date on which the local planning authority will make their self-assessment summary available under [regulation 21\(3\)](#),
- e) the date on which the local planning authority will make a notice of plan content and evidence consultation available under [regulation 23\(1\)\(a\)](#),
- f) the date on or before which representations will have to be received by the local planning authority in accordance with [regulation 23\(4\)](#) (consultation on proposed local plan content and evidence),
- g) the date on which observations and advice will be sought under section 15CA(3) of the Act in accordance with [regulation 26](#) (gateway 2),
- h) the date on which the local planning authority will make a notice of proposed local plan consultation available under [regulation 27\(1\)\(a\)](#),
- i) the date on or before which representations will have to be received by the local planning authority in accordance with [regulation 27\(4\)](#) (consultation on the proposed local plan),
- j) the date on which observations and advice will be sought under section 15CA(3) of the Act in accordance with [regulation 31](#) (gateway 3: prescribed requirements assessment),
- k) the date on which the local planning authority will submit their proposed local plan to the Secretary of State for independent examination under section 15D(1) of the Act, and
- l) the date on which the local planning authority will consider adopting the proposed local plan under section 15EA of the Act.

Design Code

Chesterfield Borough Council is not currently considering preparing an area wide Design Code. We anticipate meeting this requirement through the review and updated of Local Plan policies on design and amenity (both general and site specific), the updating of existing Residential Design Guidance (the ‘Successful Places’ guide) and preparing additional design guidance for specific sites and types of development.

Supplementary Plans

There are no other supplementary plans which are being prepared or are planned at the time of writing.

There is currently no intention to prepare any joint local plan.
