Community Infrastructure Levy (CIL) Annual Report

Report for Financial Year 2018/19

1.0 Introduction

1.1 This report is Chesterfield Borough Council's Authority's Monitoring Report for the period covering 1st April 2018 – 31st March 2019.

2.0 Background

- 2.1 The Community Infrastructure Levy (CIL) is a mechanism to allow local planning authorities to raise funds from new development, in order to contribute to the cost of infrastructure projects that are, or will be, needed to support new development.
- 2.2 The Community Infrastructure Levy Regulations 2010 (as amended) (Regulation 62) require a charging authority to prepare a report in specific items of CIL income and expenditure for each financial year. The report must be published by 31 December each year on the Borough Council's website. Parish and Town Councils must produce their own CIL reports (under Regulation 62A).
- 2.3 CIL took effect in Chesterfield Borough on all CIL-liable development which was granted from 1st April 2016. Therefore 2018/19 is the third financial year in which CIL has been charged and in which CIL payments were collected.
- 2.4 No expenditure took place in 2018/19 and therefore there is no expenditure to report. Future CIL expenditure will take place in accordance with a CIL Expenditure Strategy approved by Cabinet in July 2018.)

 The CIL Expenditure Strategy sets out the process which the Council will follow in identifying the specific items of infrastructure upon which CIL revenue will be spent in order to support growth and development across the Borough. In future reporting years where there are monies that have been spent/transferred, the AMR will set out the details.
- 2.5 CIL contributions only begin to be payable upon commencement of those CIL-liable schemes approved since 1st April 2016. In the first charging year of the CIL scheme CIL revenues were received only from a very limited number of initial developments which were approved after 1st April 2016 and which have commenced on site. CIL revenues accelerated during the second and third CIL charging years as more CIL liable developments reached commencement stage. Table 1 below shows the CIL monies received in 2018/19 financial year.

3.0 Future Reports

- 3.1 The 2019 amendments to the CIL Regulations (which came into effect on 1 September 2019) require CIL charging authorities to publish an annual infrastructure funding statement by 31st December each year. This will include:
 - An infrastructure list, (a statement of the infrastructure projects or types of infrastructure which the council intends will be wholly or partly funded by CIL)
 - A report on CIL income for the previous financial year
 - A report on planning obligations for the previous financial year
- 3.2 The first infrastructure funding statement for Chesterfield will be published by 31st December 2020 for the period covering 1st April 2019 31st March 2020.
